

**RMK MARİNE GEMİ YAPIM SANAYİİ VE DENİZ TAŞIMACILIĞI
İŞLETMESİ ANONİM ŞİRKETİ PRIVACY NOTICE FOR COMMUNICATION PROCESSES**

a) Data Controller

Your personal data may be processed by RMK Marine Gemi Yapım Sanayii ve Deniz Taşımacılığı İşletmesi Anonim Şirketi ("**Company**") as the data controller in accordance with the Personal Data Protection Law No. 6698 ("**Law**") within the scope specified below.

b) Purposes and Legal Grounds for Processing Personal Data

The collected personal data may be processed for the following purposes ("**Purposes**") and legal grounds and within the scope of the personal data processing conditions and purposes specified in Article 5 of the Law.

Based on the legal ground that it is expressly provided by the laws and is necessary for fulfilment of the legal obligation to which the data controller is subject;

- Your identity, contact, transaction security and customer transaction data for the purpose of fulfilling the requests of official authorities,
- Your identity, contact, transaction security and customer transaction data for the purpose of providing information to the competent official authorities pursuant to the legislation,
- Your identity, contact, transaction security and customer transaction data for the purpose of ensuring compliance with the retention obligations stipulated in the legislation,
- Your identity, contact, transaction security and customer transaction data for the purpose of responding to data subject requests in accordance with the legislation and taking necessary actions.

Based on the legal ground that processing of data is necessary for the legitimate interests pursued by the data controller, provided that this processing shall not violate the fundamental rights and freedoms of the data subject;

- Your identity, contact and request/complaint data for the purpose of answering the questions you submit via the contact form,
- Your identity, contact and request/complaint data for the purpose of receiving, evaluating, and finalizing your complaints, requests, suggestions and requests and planning and executing the necessary work with the relevant business units and parties for this purpose.

Based on your explicit consent;

- Processing your identity, contact, and marketing data for the purpose of carrying out the marketing processes of the Company's products and services, to recommend and promote the products and services offered, including profiling and analysis activities, by customizing them according to your tastes, usage habits and needs.
- Processing your identity and contact information for the purpose of sending commercial electronic messages via SMS, call, and e-mail.

c) Recipient Parties and Purposes for Transferring Personal Data

Your collected personal data may be transferred for the above-mentioned Purposes, to our business partners, to legally authorized public institutions and private individuals within the scope of expressly provided by the laws and is necessary for fulfilment of the legal obligation, based on your explicit consent, to service providers for the purpose of conducting communication and promotional activities pursuant to the data processing conditions specified in Article 5 of the Law and in accordance with the rules regarding the transfer of personal data specified in Article 8 of the Law.

d) Method for the Collection of Personal Data

Your personal data may be collected in the electronic environment via contact form on the Company's website and e-mail channels within the scope of fulfilling the above-mentioned Purposes.

e) Data Subject's Rights Specified under Article 11 of the Law

We hereby declare that as personal data subjects, you are entitled to the following rights, set forth under Article 11 of the Law:

- To learn whether your personal data is being processed,
- To request information if your personal data has been processed,
- To learn the purpose of the processing of your personal data and whether they have been used accordingly,
- To learn which third parties domestic or abroad your personal data has been transferred to,
- To request rectification in case your personal data has been processed incompletely or inaccurately and to demand the operations in this regard be reported to third parties your personal data has been transferred to,
- To demand the erasure or destruction of your personal data in the event that the reasons requiring their processing cease to exist, even though they have been processed in accordance with the Law and other relevant legal provisions, and, within this scope, to demand that the operations carried out, as well as in cases where your personal data have been processed incompletely or inaccurately, be notified to third parties to whom your personal data have been transferred,
- To object to negative consequences to you that are concluded, because of analysis of the processed personal data through solely automatic systems,
- To demand compensation for the damages that you have suffered because of an unlawful processing of your personal data.

You may convey your requests regarding the above-mentioned rights directly to our Company, or by filling out the Data Subject Application Form available on our website and submitting it through <https://www.rmkmarmine.com.tr/ilgili-kisi-basvuru-formu-en.pdf>, and depending on the nature of your request, your application will be finalized by the data controller you have applied to as soon as possible and, in any case, within thirty days at the latest, free of charge. However, if the process requires an additional cost, a fee may be charged in accordance with the tariff determined by the Personal Data Protection Board.
